THE NAPIER DISTRICT MASONIC TRUST RENTAL PROPERTIES

1. The Trust operates a rental property at:

8 Morris Spence Avenue, Onekawa, Napier
– bedsits and one bedroom properties.
2. Rentals charged vary according to type of unit. For example:
\$368.33 per month for a bedsit flat. (\$88.20 per week)
\$476.66 per month for a one bedroom unit. (\$113.05 per week)
(Rental figures are current as of 01st November 2018 and are reviewed annually.)
3. A bond of two weeks rent is payable prior to occupancy, and two weeks rent is payable in advance.
4. A bedsit flat typically has a curtain separating the sleeping and living areas, a kitchen and bathroom. Bedsit tenants share communal laundries.
5. A one bedroom flat has a separate lounge, bedroom, small kitchen and bathroom plus laundry area.
6. Dogs are not allowed.
7. Residents are responsible for their own garden area and expected to keep their flat clean and tidy. They are not to disturb other tenants in the complex and noise is to be kept at a minimum.
8. The Trust is responsible for lawn mowing, maintenance of all buildings and chattels belonging to the Trust.
